Position Summary:

The Legislative and Policy Team works with multiple stakeholders to turn our detailed research and policy analysis into a comprehensive legislative and policy agenda that aims to make Texas the best state for hard-working people and their families. You'll join a team of policy experts to learn the ins and outs of policymaking in Texas.

This paid fellowship is a unique opportunity to gain experience in legislative advocacy and strategy from the perspective of a multi-issue public policy organization. The fellow will work with the Chief of Legislative Affairs to advance Every Texan's policy objectives at the state, local, and federal levels. The ideal fellow is proactive, energetic, flexible, and strategic. Applicants should have strong writing and research abilities, solid time management,organizational skills, and a passion for public policy.

Roles and Responsibilities:



- Assist in developing long- and short-term legislative advocacy strategy and implementation plans.
- Maintain Every Texan's legislative calendar and help coordinate internal and external meetings, briefings, and events.
- Support Every Texan's campaigns and projects on health care coverage, tax policy, and other issues as needed.
- Provide general support for the Legislative and Policy Team and Every Texan policy staff.
- Administrative support of the Chief of Legislative Affairs for legislative and policy meetings. Duties include sending out reminders, keeping notes, and assisting with scheduling.
- Assist in drafting and proofreading monthly legislative newsletters.
- Execute legal research, including updating Lege and Policy teams on relevant litigation related to our policy areas.
- Distribute products at the Capitol as needed.

- Attend various coalition meetings as schedule permits.
- Attend weekly calls with our Community Engagement Coordinator to learn more about policy advocacy.
- Assist in the creation of a policy agenda.

The fellow will have the opportunity to work with and learn from Every Texan staff members who oversee various policy, development, and communications activities, and acquire an understanding of how a nonprofit policy organization works. The fellow may also have the opportunity to engage with Every Texan staff in support of their policy advocacy and research projects.

Required Qualifications:

Every Texan fellows must be a current undergraduate at a higher education institution or graduate student.

- Fellows must be based in Texas.
- This fellowship is open to international students with temporary employment authorization.
- **Commitment to social justice and racial equity.** You believe that improving outcomes for all Texans requires local and state policies that correct injustices and promote equity.
- **Demonstrated interest in the legislative process**. You have experience developing and/or executing advocacy strategy, and you enjoy working collaboratively with diverse stakeholders..
- Ability to juggle a wide range of tasks across multiple projects. You can multitask effectively.
- Ability to communicate clearly. You are able to synthesize complex ideas concisely.
- Self Starter. You pay attention to team needs and anticipate helpful contributions.



Compensation:

This position is funded at \$15/hour for up to 20 hours per week. As temporary employees, fellows are entitled to Every Texan's paid holidays if a holiday falls on a day they would otherwise have worked and accrue sick leave based on hours worked. Fellows are not entitled to any other employee benefits, including vacation leave, health and life insurance, and employer-sponsored pension. Fellows will be paid in accordance with Every Texan's normal payroll practices and be subject to the usual, required withholding.

Status:

- Part-time (up to 20 hours per week)
- This position is eligible for remote work for Texas-based students, though ability to work from Austin is preferred.

Compensation: This position is funded at **\$15/hour** and has a target start date of **Fall 2024**. Every Texan offers excellent benefits, including health insurance, dental insurance, life and long-term disability insurance, retirement contributions, and generous vacation, leave, and holidays.

Your writing sample should show that you can write about complex content in a way that is targeted to readers who do not know about the topic (i.e., simple, clear, concise). Please email applications with attachments in Microsoft Word or PDF format only. We do not accept phone inquiries regarding the position. Applications will be reviewed on a rolling basis. Thank you!
